All therapy fees (including session fees and/or co-pays, if applicable) are due at time of service, unless alternative arrangements are made in writing ahead of time. Clients who pay in full at time of service receive a 10% prompt pay discount for services.

I understand that I am responsible for all costs / fees that any third-party payer (ex. insurance company, private school, etc.) does not cover. In the event that a third-party payer source determines that rendered therapy services are “not covered” or otherwise denied, I will be responsible for all outstanding charges. I understand that I will be billed accordingly and will be responsible for immediate payment. I also understand that Alexander Speech and Hearing, LLC will not become involved in disputes between my and my third-party source regarding uncovered charges or reasons for denial.

I understand that if fees are not paid in full, treatment sessions may be postponed or cancelled until payment is received.

I understand that all returned checks will be subject to a **\$25** returned check fee. Charges incurred and not paid after **30** days may be turned over to a collection agency at the client’s expense. Overdue accounts may also be reported to a Credit Bureau.

I understand that I am responsible for all legal and collection fees, which Alexander Speech and Hearing, LLC may incur if payment is not made in accordance with the terms and conditions herein.

I understand that refunds will be issued only in instances of overpayment. All refunds will be processed within 1 week after the overpayment is discovered on the client’s bill or at the time the refund is requested. Refunds for payments made with a credit card will be credited back to the credit card used, all other refunds will be issued by a check. Client’s who used a third-party source will not be issued a refund until full payment is received from the appropriate source.
